Performance Commentary

EM assets had a tough month in August as declines in Turkey and Argentina in particular sparked fears of global contagion. EM currency weakness was the theme of the month. A weak lira continued to hurt our Turkish holdings, including Sabanci. Currency weakness was also a major negative contributing factor to our Brazilian holdings Cosan and Marfrig. Marfrig also disappointed with a lower price tag than expected on the sale of US subsidiary Keystone. South African internet conglomerate Naspers' share price was up in ZAR terms despite regulatory pressures on core holding Tencent, but rand weakness influenced negatively also here. Sentiment around Samsung Electronics was positive, as the market is incorporating a "stronger for longer" cycle in the key memory division. Turnaround story Ericsson is finally getting some traction from encouraging results. Indian agrochemical company UPL was strong after announcing the acquisition of Arysta.

We aim to increase the turnover velocity of the fund by lowering the threshold to add new positions. This resulted in 2 new holdings in August. We are also implementing a more systematic risk management process to avoid unintended portfolio risks. We currently see almost 50% upside to the portfolio with a 2-year investment horizon. The portfolio trades at around 8x 19e P/E, which is a more than 25% discount to EM and compares to 15x for DM.

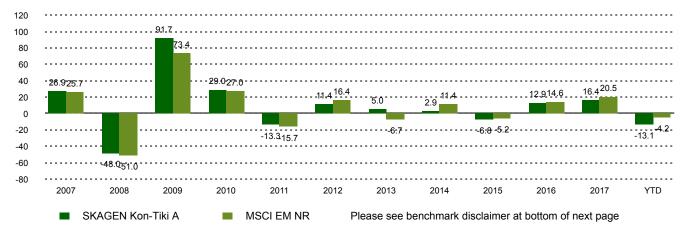

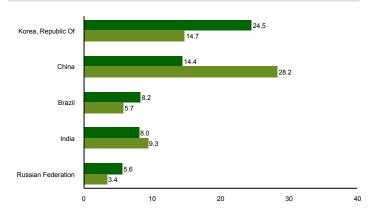

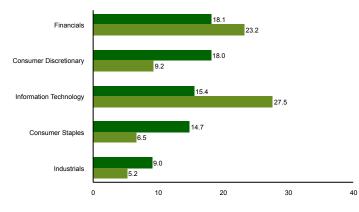
